#### Lease Abstraction

As the deadline for lease accounting standard ASC 842 looms closer for private companies – December 15, 2022 - we remain focused on assisting businesses with their compliance and adoption. The new requirements have increased the complexity of accounting for leases, particularly affecting the areas of lease administration and data abstraction.



What this means is that all important and necessary lease data will need to be added to the accounting system to ensure compliance with the standard. Lease abstraction is a complex and time-consuming exercise. Sifting through voluminous leases by the required deadline can pose significant challenges for many companies.

The Trace Forensic Experts team has developed a tried and tested process for lease abstraction, that includes: Identifying the population and subpopulations of leases; document clustering; pattern field recognition; identification of relevant clauses; and accelerated manual review, coupled with machine learning.

We assist our clients with understanding and complying with the accounting requirements of the new lease standard; extracting high volumes of critical information from leases within a short period; the abstraction process; and continued maintenance of lease portfolios.
